RESTART

THE PRINCIPLE OF COMPENSATION IN FRENCH LAW IS THAT OF FULL REPARATION.

The victim should receive financial compensation allowing them to regain their previous quality of life, adapted to their new disability.

The option for a tetraplegic person

not to be moved to a nursing home if he does not wish to do so, and to have his home adapted to his disability, in particular by adding a living space for the staff who take it in turns to assist him 24 hours a day, all of which is paid for by the insurance.

The right of a young paraplegic woman

to receive additional human care during her pregnancy.

The construction of a single-storey house

for a burn victim who has lost the ability to walk and was living on the second floor of a building without a lift before the accident.
